Animated ads are not permitted at this time.

## Sponsorship Agreement for ModernPhoenix.net

- 1) **Advertisement** – means the graphic file supplied by an advertising client (“Sponsor”), or created by Modern Phoenix which can be selected by a user as a link.
- 2) **Sponsor** – means the individual or entity listed on the first page of this agreement.
- 3) **Advertising Fee** – The local administrator will govern the rate indicated on the contract. Rates are guaranteed through September 30, 2009.
- 4) **Advertising Space** – means the space reserved on the ModernPhoenix.net website
- 5) **Fees** - All amounts are payable in United States dollars via check or PayPal.
- 6) **Right to refuse unacceptable advertising** – Modern Phoenix and/or its agents reserves the right to refuse any advertisement it deems inappropriate or that does not conform to its graphic specifications. Modern Phoenix and/or its agents will not accept any sponsors or advertisements that promote pornography, violence or hate. Modern Phoenix and/or its agents also do not accept advertising for Tuscan style, Santa Fe, Spanish, Mission, Soft Loft, or Mass-market contemporary style architecture and furnishings. This is not an exhaustive list and is subject to Modern Phoenix and its agents’ discretion. All graphics must be within the file size and dimension restrictions listed in this agreement. Modern Phoenix and/or its agents may request changes to any advertisement it deems unacceptable. Such a request does not constitute a termination of this agreement and will not affect the enforceability of any of its provisions.
- 7) **Responsibility of copy** – The Sponsor agrees to indemnify and hold harmless Modern Phoenix and /or its agents from any liability, loss and expense of any nature arising out of the display of any graphics, text, display and illustrations supplied by the Sponsor or Modern Phoenix.
- 8) **Start Date** – means the first date the Advertisement appears on the Modern Phoenix website.
- 9) **Term Guarantee** – Modern Phoenix guarantees that the advertising space specified on this agreement will be available for the length of time (start date to renewal date as noted on the front of this agreement) stipulated herein.
- 10) **Upgrading of advertisement** – after entering into this agreement, the Sponsor may request an upgrade of the advertisement space from Standard to Premium at any time. An upgrade of advertisement space will constitute a termination of this agreement and a commencement of a new agreement at the rates and on the terms in effect at the time of the upgrade. The upgrade will commence upon receipt of payment and delivery of new artwork. The difference between the former advertising rate and the new advertising rate will be pro-rated and invoiced to the Sponsor accordingly. The Sponsor may not request a downgrading of advertising space during the tenure of the agreement. Any requested change to a current contract must be received in writing.
- 11) **Responsibility of payment** -- The Sponsor is responsible to pay Alison King of Modern Phoenix. The banner ad will appear on the Modern Phoenix website hosted on modernphoenix.net within 48 hours of Modern Phoenix receiving full payment and ad artwork from the Sponsor.
